Open Session – for consideration

5-7 July 2024

1. DIGITAL HEALTH

WIDE BAY REGION

That this Convention of the LNP calls upon the next LNP State Government to ensure the full implementation of Digital Health across all Queensland Health and Hospital Services within two years of coming to office.

2. AGE OF CRIMINAL RESPONSIBILITY

GREENSLOPES SEC

That this Convention of the LNP calls upon the next LNP State Government to oppose any moves to increase of the age of criminal responsibility in Queensland.

3. FIRST HOME OWNER STAMP DUTY EXEMPTION

McPHERSON FDC

That this Convention of the LNP calls upon the next LNP State Government to make home ownership more affordable for first home buyers through the implementation of a first home owner stamp duty exemption for properties up to an agreed value, reflective of market house prices in Queensland.

4. APPRENTICESHIPS AND TRAINEESHIPS

PSC - EDUCATION

That this Convention of the LNP calls upon the next LNP State Government to establish an independent governing body to oversee apprenticeships and traineeships in Queensland to:

(a) address workforce shortages, improve outcomes for apprentices, trainees, employers and industry; and

(b) to manage the establishment of the Year 10 “Try-a-Trade” scheme to provide young people with exposure to a wide range of work.

5. ANTENATAL HEALTH

LNP WOMEN

That this Convention of the LNP calls upon the next LNP State Government to:

(a) promote antenatal health; and

(b) ensure every baby is given the same start in life by offering a Baby Box to pregnant women when they attend an antenatal clinic for their 18 to 20 week or 28-week appointment, and if appropriate, to the adoptive parent/foster carer.

6. SHERIFF OFFICE

PSC - PUBLIC SAFETY

That this Convention of the LNP calls upon the next LNP State Government to establish a Queensland Sheriff’s Office with similar functions and responsibilities as interstate Sheriff Offices.

7. HOUSING TARGETS

YOUNG LNP

That this Convention of the LNP calls upon the next LNP State Government to implement a version of the Conservative Party of Canada’s NIMBY Penalty policy to fine local councils that fail to approve housing construction in line with housing targets, and reward councils that appropriately exceed housing targets with additional infrastructure and development funding.

8. JUNIOR SPORT

MORETON FDC

That this Convention of the LNP calls upon the next LNP State Government to offer assistance to low-income families to participate in junior sports, in the form of the present \$150 voucher system or by incentivising sporting peak bodies to commit resources.

9. DEPARTMENT OF CHILD SAFETY

METRO SOUTH REGION

That this Convention of the LNP calls upon the next LNP State Government to amend the laws governing the Department of Child Safety so that the safety, health and well-being of children is prioritised over other considerations.

That this Convention of the LNP calls upon the next LNP State Government to legislate that each Neighbourhood Watch is allocated a police officer to attend their meetings.

11. SCHOOL HEARING TESTS

SOUTHERN DOWNS SEC

That this Convention of the LNP calls upon the next LNP State Government to reintroduce hearing tests to state schools.

12. SMALL HOME DEVELOPMENT

McPHERSON FDC

That this Convention of the LNP calls upon the next LNP State Government, as part of a comprehensive Cost of Living and Housing Affordability Package, to encourage granny flat and tiny home development.

13. BEST PRACTICE INDUSTRY CONDITIONS - BUILDING

ALGESTER SEC / OXLEY FDC

That this Convention of the LNP calls upon the next LNP State Government to undertake a financial review of the Standard Best Practice Industry Conditions – Building. Construction Projects 2023 – 2027.

14. PIONEER VALLEY PUMPED HYDRO PROJECT

MIRANI SEC

That this Convention of the LNP calls upon the next LNP State Government to implement a moratorium on the purchase or resumption of land for the Pioneer Valley Pumped Hydro infrastructure project before a full business case and cost analysis have been completed, and necessary State and Federal approvals have been received.

15. NATIONAL SECURITY COMMITTEE

PSC - NATIONAL SECURITY, DEFENCE AND VETERANS' AFFAIRS

That this Convention of the LNP calls upon the next Federal Coalition Government to restore Australia's directors general of domestic and foreign intelligence agencies as permanent members of the National Security Committee of Cabinet.

16. AUDIT OF MENTAL HEALTH SERVICES

GROOM FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to audit all government-funded mental health services, to ascertain their effectiveness in building employment capacity, medical intervention and links in the community.

17. REDUCED IMMIGRATION

SUNSHINE COAST REGION

That this Convention of the LNP calls upon the next Federal Coalition Government to reduce net migration, including permanent and temporary migration.

18. IMPORTATION OF FAKE ABORIGINAL ART

McPHERSON FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to prohibit the importation of any goods labelled as, or looking like, Australian Aboriginal art or products.

19. SUBSIDISED REGIONAL TRANSPORT

PSC - TRANSPORT AND ROADS

That this Convention of the LNP calls upon the next LNP State Government to review subsidised air, bus and rail schemes in Regional Queensland, to identify improvements with service delivery, intermodal connectivity, ticketing and tourism facilitation.

20. LEGAL USE OF PEPPER SPRAY

GRIFFITH FDC / LILLEY FDC

That this Convention of the LNP calls upon the next LNP State Government to remove pepper spray as a restricted weapon from the Weapons Act 1990 and make it legal to use in self-defence.

21. SPEED CAMERA WARNING SIGNS

CALLIDE SEC

That this Convention of the LNP calls upon the next LNP State Government to install warning signs before and after mobile and transportable speed cameras to remind motorists to check their speed and to adhere to the speed limit.

22. STATE GOVERNMENT PROCUREMENT SYSTEMS

COOPER SEC

That this Convention of the LNP calls upon the next LNP State Government to review the Queensland Government procurement systems and data portals with an aim of having a single transparent system for both managing tender opportunities with suppliers and disclosure of all awarded reportable contracts.

23. BIOSECURITY - FIRE ANTS

CONDAMINE SEC

That this Convention of the LNP calls upon the next LNP State Government to conduct a thorough analysis on the spread of fire ants and fundamentally overhaul the biosecurity response and action times when detection occurs.

24. BIOSECURITY CHECKPOINT

PSC - PRIMARY INDUSTRIES

That this Convention of the LNP calls upon the next LNP State Government to review the closure of the Cape York Biosecurity Centre at Coen.

5. REVIEW OF LOCAL GOVERNMENT ACT

GREGORY SEC

That this Convention of the LNP calls upon the next LNP State Government to urgently review the Local Government Act.

26. PLACE NAMES

MANSFIELD SEC / METRO SOUTH REGION

That this Convention of the LNP calls upon the Brisbane City Council and the next LNP State and Federal Coalition Governments to retain existing place names unless change is supported by a majority of residents of the locality, and that significant public institutions (eg Tourism Australia, ABC, airports) be discouraged from the confusing practice of using dual existing and place names.

27. THIRD PARTY INSURANCE

BANCROFT SEC

That this Convention of the LNP calls upon the next LNP State Government to adopt a policy of third party property car insurance, whereby if an uninsured motorist shall damage by collision, another motorist's property, they shall be required to pay for that damage, before registering or re-registering a vehicle in Queensland.

28. CRIME INTERVENTION IN POLICE DISTRICT SCHOOLS

WHITSUNDAY SEC

That this Convention of the LNP calls upon the next LNP State Government to legislate that as a crime prevention tactic, early intervention and connection is a priority in every police district's schools.

29. BIRTHS DEATHS AND MARRIAGES ACT

LNP WOMEN

That this Convention of the LNP calls upon the next LNP State Government to remove Part 5 Acknowledgement of Sex from the Births, Deaths and Marriages Registration Act 2023 noting sex is binary, male or female, and is not assigned, but is part of human sex characteristics and is unchangeable.

30. CADET PROGRAM IN SCHOOLS

WIDE BAY REGION

That this Convention of the LNP calls upon the next LNP State Government to expand the cadet program in schools.

31. SERVICE LEVEL AGREEMENTS

MERMAID BEACH SEC

That this Convention of the LNP calls upon the next LNP State Government to implement service level agreements within city and town plans that require local authorities to approve or deny planning applications within a commercially viable timeframe, and that delays are published in real time by the Local Government Authority and attract a daily financial penalty that is payable to the developer.

32. SUGAR INDUSTRY MANAGEMENT

MIRANI SEC

That this Convention of the LNP calls upon the next LNP State Government to assess the Queensland sugar industry's preparedness to adopt advancements and innovations towards a decarbonised industry, and adopt best practices management.

33. SUPPORT FOR ISRAEL

GYMPIE SEC / LNP WOMEN

That this Convention of the LNP calls upon the LNP State Parliamentary Team and Federal Coalition to condemn the actions against Jewish people in Australia and provide unwavering support for Israel.

34. WORK BONUS CAP

CAPRICORNIA FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to allow the Work Bonus cap to be shared between a pension couple.

35. ECONOMIC SECURITY

CURRUMBIN SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to publish a White Paper into Australia's economic security framework and planning, as well as to establish a dedicated Economic Security Agency to sit within the National Intelligence Community.

36. DEFENCE FORCE FIRST

GLASS HOUSE SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to adopt a policy of "Defence Force First", whereby:

- (a) the budgetary needs of the ADF over the forward estimates are given the highest priority;
- (b) the immediate procurement and capability needs of the ADF are prioritised above Australian industry policy and parochial electoral interests; and
- (c) the personnel and recruitment needs of the ADF are fulfilled by whatever means necessary.

37. FUEL EFFICIENCY STANDARD

MANSFIELD SEC / METRO SOUTH REGION

That this Convention of the LNP calls upon the next Federal Coalition Government to repeal the requirement that new light vehicles comply with the Euro 6 vehicle emissions standard from 1 December, 2025, and to remove the Fuel Efficiency Standard (FES) which is effectively a carbon tax on heavier vehicles to force take up of electric vehicles (EVs) and hybrids.

38. PHARMACY LOCATION RULES

GRIFFITH FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to amend the Pharmacy Location Rules to remove the stipulation that no pharmacy may open within 1.5 kilometres of an existing pharmacy.

39. BIOSECURITY AT ADF BASES

CONDAMINE SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to review and overhaul biosecurity measures in place at Australian Defence Force installations, particularly where it pertains to invasive pests such as fire ants.

40. BAN OF PUBERTY BLOCKERS TO MINORS

GROOM FDC / LNP WOMEN

That this Convention of the LNP calls upon the next LNP State and Federal Coalition Governments to follow the recommendations of the UK Cass Review and ban puberty blockers to minors with gender dysphoria, outside of clinical research trials.

41. IMPROVING THE BRUCE HIGHWAY

CAPRICORNIA FDC

That this Convention of the LNP calls upon the next LNP State and Federal Coalition Governments to commit to a 10 year plan towards improving the Bruce Highway to a national standard of safety.

42. YOUTH PARTICIPATION IN SPORT

METRO SOUTH REGION

That this Convention of the LNP calls upon the next LNP State Government to explore the capacity and process to materially assist young people, who are likely to be attracted to youth crime, to participate in community sport.

43. TAXATION THRESHOLDS

REDLANDS SEC

That this Convention of the LNP calls upon the next LNP State Government to implement a policy whereby the thresholds for State Taxes, especially Payroll Tax and Land Tax, be indexed annually by the CPI as at 1 July.

44. MAINTENANCE OF MAJOR ROADS

PSC - TRANSPORT AND ROADS

That this Convention of the LNP calls upon the next LNP State Government to ensure highways and major arterial roads are engineered and maintained in consultation with local councils and regional TMR offices to ensure their design and maintenance standards are appropriate for the projected traffic demands, development zonings and local soil conditions.

45. BAIL ACT

LILLEY FDC

That this Convention of the LNP calls upon the next LNP State Government to amend section 16(1AA) of the Bail Act refusal of Bail and remove the term "adult", making it apply equally to youths and adults.

46. HOME INVASION COURT

METRO SOUTH REGION

That this Convention of the LNP calls upon the next LNP State Government to create a specialised, fast-track "Home Invasion Court" to deal with the current Queensland crime wave of home invasions involving crimes related to personal injury, property theft and damage.

47. INQUIRY INTO DECLINING STANDARDS

BUDERIM SEC

That this Convention of the LNP calls upon the next LNP State Government to initiate an inquiry into the state education system, to determine why students are alienated and why our international scores are declining.

48. CONVERSION OF UNUSED OFFICE SPACE

CHATSWORTH SEC

That this Convention of the LNP calls upon the Brisbane City Council to investigate the feasibility of converting unused business office space to residential use, including where necessary, the relaxation of rules and fees to make it appealing for developers and building owners.

49. LAND TAX

MOGGILL SEC

That this Convention of the LNP calls upon the next LNP State Government to increase the minimum threshold for Land Tax in Queensland and increase the Land Tax Bands.

50. WOMEN'S SPORT

REDCLIFFE SEC

That this Convention of the LNP calls upon the next LNP State Government to protect the involvement of women in sport.

51. AMENDMENT TO PENALTIES AND SENTENCES ACT

YOUNG LNP

That this Convention of the LNP calls upon the next LNP State Government to amend:

(a) Part 6 Section 114(2A) of the Penalties and Sentences Act 1992 (Qld) to increase the requirement for rehabilitation programs and community service activities an offender must complete to satisfactorily adhere to an Intensive Corrections Order; and

(b) Part 2, Section 9(6A) of the Penalties and Sentences Act 1992 (Qld) to remove reliance on good character reference for child sex offenders.

52. VOCATIONAL EDUCATION STANDARDS AUTHORITY

PSC - EDUCATION

That this Convention of the LNP calls upon the next LNP State Government to create the Queensland Vocational Education Standards Authority (QVESA), to assume the powers of the Australian Skills Quality Authority (ASQA), to ensure the registration and regulation of privately owned Queensland Registered Training Organisations (RTOs) are fairly, equitably and proportionately regulated.

53. VETERANS CARE PROGRAM

OXLEY FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to implement a system whereby the Department of Veterans Affairs, in conjunction with Medicare, pay Coordinated Veterans Care Program claims based on service date, to service providers.

54. COAL TO UKRAINE

GRIFFITH FDC

That this Convention of the LNP calls upon the Federal Coalition to support Ukraine's request for an urgent shipment of coal and to support Ukraine's future requests for coal.

55. ESAFETY COMMISSION

LNP WOMEN

That this Convention of the LNP calls upon the next Federal Coalition Government to abolish the eSafety Commission and any legislation that controls information.

56. RURAL HEALTH

WIDE BAY REGION

That this Convention of the LNP calls upon the next LNP State and Federal Coalition Governments to work with Primary Health Networks, universities and specialist training colleges, to increase the number of training positions for nurses, rural GPs and rural specialists.

57. REINTRODUCTION OF AG VISA

KENNEDY FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to reintroduce a Dedicated Agricultural Visa, to alleviate the severe work force shortages that confront farmers across Australia.

58. TROOPS TO TEACHERS

MAIWAR SEC

That this Convention of the LNP calls upon the next LNP State Government to explore a pathway for military retirees to undertake training which allows them to transition to teachers, with a major focus on difficult-to-staff schools.

59. FAIR WORK ACT

GROOM FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to develop an alternative act to the existing Fair Work Act 2009 that creates simple, fair and productive employment legislation that is fit for purpose in a modern economy.

60. FIRST HOME BUYERS

YOUNG LNP

That this Convention of the LNP calls upon the next Federal Coalition Government to implement a version of Canada's First Home Savings Account policy to allow prospective first home buyers to save for a house deposit through a tax-free savings account.

61. ADF NATIONAL DISASTER MANAGEMENT

TOOWOOMBA SOUTH SEC

That this Convention of the LNP calls upon the next LNP State and Federal Coalition Governments to conduct a cost/benefit analysis on the recommendations of the Royal Commission into National Disaster Arrangement (28 October 2020), particularly pertaining to appropriate, interoperable and sustainable capabilities utilised by the Australian Defence Force that should be the responsibility of the state to provide. These capabilities being, fixed and rotary wing tactical airlift, light to medium sealift and all terrain land based vehicles.

62. POLICE STATION STAFFING

WIDE BAY REGION

That this Convention of the LNP calls upon the next LNP State Government to review and determine the required numbers of operational police officers to effectively resource police stations statewide where required on a 24/7 basis.

63. COMMUNITY SERVICE INDUSTRY ACT

METRO SOUTH REGION

That this Convention of the LNP calls upon the next LNP State Government to amend the Community Services Industry (Portable Long Service Leave) Act 2020 to reduce the negative cash flow impact on small and medium sized registered charitable organisations.

64. QUEENSLAND HERITAGE REGISTER

MACKAY SEC

That this Convention of the LNP calls upon the next LNP State Government to develop a tiered administration system for buildings listed on the Queensland Heritage Register.

65. RACING QUEENSLAND

MORETON FDC

That this Convention of the LNP calls upon the next LNP State Government to commit to a review and overhaul of Racing Queensland after years of stakeholder dissatisfaction regarding botched upgrades of racetracks, insufficient numbers of lower-grade races, lack of jockeys in regional and rural areas, and unfair distribution of prize money.

66. NURSING DEGREES

LNP WOMEN

That this Convention of the LNP calls upon the next LNP State Government to urgently review Bachelor of Nursing and combined Bachelor of Nursing/Bachelor of Midwifery degrees in Queensland, to address issues including student retention rates.

67. SOCIAL MEDIA ALGORITHMS

PSC - SCIENCE AND INNOVATION

That this Convention of the LNP calls upon the next Federal Coalition Government to investigate the possibility of limiting social media algorithms aimed at children aged 16 and younger, by looking at social media companies and their algorithms, rather than relying on the requirement for Australians to give their personal identity documents to third-party registries.

68. TAX DEDUCTION FOR SPORT FEES

COOPER SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to allow parents/carers to claim a tax deduction of up to \$500.00 for the cost of registration fees for children/dependants under 18 to play sport with a registered sporting club or organisation.

69. CORPORATE TAX RATE

YOUNG LNP

That this Convention of the LNP calls upon the next Federal Coalition Government to reduce the corporate tax rate to a globally competitive setting of 25% for all companies, noting that this would attract investment, drive growth and mitigate the disincentives of the two-tier tax system.

70. POWER CONNECTION DELAYS

LOCKYER SEC

That this Convention of the LNP calls upon the next LNP State Government to review the electricity regulators and fix delays in connections across Queensland.

71. PROFESSIONAL SERVICES REVIEW

PSC - HEALTH

That this Convention of the LNP calls upon the next Federal Coalition Government to review and revise the Professional Services Review System, to ensure natural justice for the doctors being reviewed.

72. STATE FUNDED INFRASTRUCTURE

MERMAID BEACH SEC

That this Convention of the LNP calls upon the next LNP State Government to fund state infrastructure to support a growing population so that local governments do not carry an unsustainable financial burden of domestic and international migration.

73. MANAGED FORESTRY PLANTATIONS

PSC - PRIMARY INDUSTRIES

That this Convention of the LNP calls upon the next LNP State Government to recognise the strategic importance of the State's managed forestry plantations for the supply of building materials, and commits to no net reduction in the number of hectares of forestry plantations on state owned land.

74. FUEL SECURITY AND PRICING

CAPALABA SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to establish a fuel inquiry to encompass both fuel security and pricing, with the aim to:

- (a) increase fuel security and hence national security; and
- (b) ends the "price cycle" and price gouging.

75. FINANCIAL SCAMS

LOCKYER SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to ensure that financial institutions adopt best practice in preventing and addressing financial scams and crimes.

76. TELEHEALTH CONSULTATION

YOUNG LNP

That this Convention of the LNP calls upon the next Federal Coalition Government to permanently reinstate the temporary provision introduced during the COVID-19 pandemic to allow initial telehealth consultations with a medical practitioner to be claimed on the Medicare Benefits Schedule.

77. TRANSPARENT HECS FEES

WEST MORETON REGION

That this Convention of the LNP calls upon the next Federal Coalition Government to require universities to disclose in marketing and promotional materials the total cost for each degree program and associated HECS debt.

78. FIRE OVERSEAS SERVICE MEDAL

PSC - PUBLIC SAFETY

That this Convention of the LNP calls upon the next Federal Coalition Government to establish a Fire Overseas Service Medal to recognise the service of paid and volunteer firefighters in prescribed events. The Fire Overseas Service Medal would complement the Police Overseas Service Medal and the Humanitarian Overseas Service Medal.

79. REMOVAL OF LEVEL CROSSINGS

PSC - TRANSPORT AND ROADS

That this Convention of the LNP calls upon the next LNP State Government to commit to a Level Crossing Removal Program, which removes all level crossings in built-up areas of South East Queensland and major level crossings in regional areas.

80. HARNESS RACING

MORETON FDC

That this Convention of the LNP calls upon the next LNP State Government to instruct Racing Queensland to urgently address the lack of harness racing tracks in South East Queensland, especially in view of the imminent closure of Albion Park before the new track at Norwell is completed.

81. CAPE YORK WORLD HERITAGE LISTING

KENNEDY FDC

That this Convention of the LNP calls upon the next LNP State Government to oppose the proposed World Heritage listing of Cape York Peninsula.

82. SELF DEFENCE IMMUNITY

WARREGO SEC

That this Convention of the LNP calls upon the next LNP State Government to legislate that landholders and householders are protected from public and criminal liability when defending homes and property.

83. CYBER THREATS

YOUNG LNP

That this Convention of the LNP calls upon the next Federal Coalition Government to urgently upgrade Australia's defence of cyber threats due to the consistencies of attacks on both public and private sectors over the last 15 years, and to implement:

(a) increases in funding and resources to the Australian Signals Directorate, Australian Security Intelligence Organisation, and the Department of Defence in improving the nation's ability to protect Australia from cyber threats and improve our cyber warfare capabilities; and

(b) significant increases of the financial punishment for public companies classified as liable for data breaches, determined in the Privacy Act 1988, instead of the current \$50 million penalty.

84. SPECIALIST REFERRALS

GRIFFITH FDC

That this Convention of the LNP calls upon the next Federal Coalition Government to extend the 12 month time limit for referrals from health professionals to specialist doctors, rather than just for chronic ongoing health conditions.

85. REGIONAL SPORT FACILITIES

MORETON FDC

That this Convention of the LNP calls upon the next LNP State Government to upgrade existing regional sports and associated facilities to attract more top-class sporting events, particularly with a view to enhancing sports tourism.

86. REMOVAL OF FUNDING FOR UNRWA

MANSFIELD SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to cease funding for the United Nations Relief and Works Agency (UNRWA) for its role in events leading up to and during the Hamas attack on Israel on 7 October 2023.

87. TAX FREE THRESHOLD

NINDERRY SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to investigate raising the tax-free threshold for simpler, lower and fairer taxes.

88. STAY AT HOME CHILD CARE

LNP WOMEN

That this Convention of the LNP calls upon the next LNP State Government to:

- (a) investigate opportunities which would make staying at home to care for children an equally valid choice to paid employment away from home; and
- (b) consider introducing income splitting tax legislation.

89. TAXATION INDEXATION BRACKETS

MAROOCHYDORE SEC

That this Convention of the LNP calls upon the next LNP State Government to reinstate indexation brackets for Land Tax, Payroll Tax and Stamp Duty, and to review the base brackets as soon as practicable.

90. LIVE SHEEP EXPORT

PSC - PRIMARY INDUSTRIES

That this Convention of the LNP calls upon the Federal Coalition to explicitly support the Live Cattle Export industry which is critical to the Queensland beef industry, and condemns the Albanese Labor Government for its phaseout of the Live Sheep Industry and legitimisation of extremist animal activism.

STAFFORD SEC

That this Convention of the LNP calls upon the next Federal Coalition Government to reduce immigration into Australia and index future migration to the parallel increase in the availability of housing, healthcare services, and law and order services such as policing and prisons.

92. POLICE RETIREMENT AGE

REDCLIFFE SEC

That this Convention of the LNP calls upon the next LNP State Government to review the mandatory retirement age of 60 years for Queensland Police, to optional age.

93. RURAL FIRE BRIGADES
